

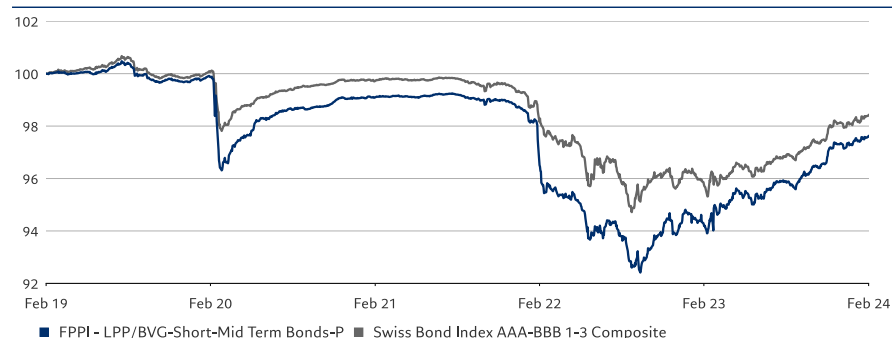

CUMULATIVE RETURN



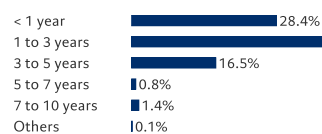

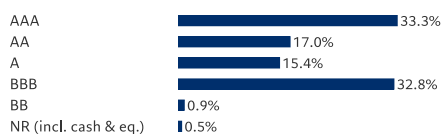
