Financial terms

Credit Suisse AG

Trailer fees: 50% of the effective management fees

Allfunds InvestLab AG

Minimum service fees: Chf 13'750 per annum*

Service fee designed as a staggered degressive fee

*In all events and irrespective of the number of ISINs or AuS, the Fund Provider shall at least pay a minimum fee of CHF 13'750.- per annum. If the yearly cumulated service fees calculated don't reach the minimum service fees above mentioned, the calculated amount is adjusted to the yearly minimum service fees.

Exempt share classes (<20bps, money market and indexed funds)

Specificities

- > Fund Provider is party to the Platform Access Agreement (with FPS) and its annex (platform particular annex) in which he adheres to Credit Suisse & Allfunds InvestLab requirements.
- > New funds to be added on the platform via Annexes (excel file) and acknowledged by the Fund Provider.
- > Product offering:
 - Minimum requirements to register the funds to public sale in CH, DE, IT; UK, ES, FR, AT (and HK, SG where reasonably applicable)
 - Funds shall be available in a variety of share classes where required by CS (Hedged, RDR, CHF, EUR, USD.
- Fund Provider/IM has to disclose the name of its distributors that uses Credit Suisse or InvestLab and its Sub-distributors as a custodian. List must be updated on a monthly basis.
 - The Fund Provider/IM undertakes to inform FPS in writing in case such a direct distribution agreement is terminated
- > Operational Specificities:
 - Mandatory monthly reporting from the Fund Provider to FPS (list of third parties with which Fund Provider has entered into agreement)
 - Fund static data with OpenFund Standards (OFS) and FundInfo
 - Quarterly trailer fee and service fee invoices from FundPartner Solutions /AFB InvestLab with its breakdown by Fund Provider (invoiced 10 BD after quarter end)
 - Deduction of holdings to calculate trailer fees subject to conditions
